

**NOTICE OF FILING OF APPLICATION UNDER THE U.S. DEPARTMENT OF LABOR'S
PERMANENT LABOR CERTIFICATION PROGRAM**

This notice is being provided as a result of the filing of an application for permanent alien labor certification for the relevant job opportunity.

Any person may provide documentary evidence bearing on the Schedule A labor certification application to the appropriate DOL office with jurisdiction over the location where the alien beneficiary will be physically working.
